## PCGT CELEBRATES WOMEN'S DAY

The program was graced by the presence of Mr. Vishwas Nangare Patil, Jt.C.P. (Law and Order), Mr. Sandeep Karnik, Addl. C.P., Dr. Swami D.C.P, and Ms. Sonali Kulkarni. The event was jointly organized by Mumbai police and PCGT. The felicitation programme was followed by street plays at Churchgate Station, Hinduja College, CST Station and Gateway of India.

## EDITORIAL



Two highlights mark this Quarter January to March 2022. Since Schools and Colleges have begun live classes, PCGT's Kuchh Aur and Youth For Governance programmes have also gone off-line after a long gap of nearly two years.

The other highlight is the Selection of our Y.F.G Project Manager Ruchi Bhagat, as a First-Class Magistrate in the Judicial Service of Maharashtra.

Ruchi was with us for eight months, enough time for her to prove her mettle. And she did this in ample measure! Her one outstanding contribution is the Constitutional Literacy Programme, which she conceived of and defined in a booklet, published by PCGT, for use in Schools and Colleges.

This innovation was greatly appreciated by our Consultant Adv. Shivan Jain Kakadia, who rejoined PCGT after a short detour and offered to carry the learning programme to many more young students. Knowledge of the Constitution of India on which our Prime Minister often swears is essential for every citizen. PCGT will spread this knowledge of the Constitution's Preamble, the basic rights of individuals and also their duties to all our students.

Our Project Managers have performed really well in this quarter. The Kuchh Aur programme of teaching values to the young at the schooling stage itself is far advanced now as we can gather from the interest shown by the young boys and girls and the reactions of our Interns who were exposed to our Trustee Rekha Shahani's efforts.

I have mentioned Ruchi who spearheaded the Y.F.G. programme and who is leaving us shortly. She was assisted by Raj Barchha who is a good outdoors man, doing much of the leg work required. The two of them helped our Campus Ambassadors in the Colleges to organize lectures on current events and invite experts to speak on the subject. They and the Mumbai Police organized an event to felicitate "Police Didis" (policewomen detailed to prevent molestation of school-going children and women in general) who had performed creditably during the year.

Street plays were put up by different Colleges in their vicinities and near Railway Stations to bring home the messages the police or the PCGT wanted to deliver.

Our Leadership Programmes have got a new lease of life with Shivam Jain Kakadia rejoining PCGT. A one-day Workshop on R.T.I and R.T.S., was organized on a Sunday when 80 students participated.

Former R.T.I Commissioner Shailesh Gandhi was the Main Speaker and he was a great draw. A Conclave on Global Peace and Security has been planned for April with Speakers lined up.

In the M.O.U PCGT had signed with the University of Mumbai we had agreed to arrange one talk on "Substance Abuse". PCGT arranged for Fr. Joe Pereira, Founder of the NGO Kripa, and a Padma Shri awardee, for that work, to speak to 600 NSS volunteers on preventive measures and steps to deal with addiction. The meeting was also addressed by a former addict who was rehabilitated by Fr. Joe Pereira's organization. His recount of what he had experienced made a strong impression on the audience.

The scourge of Manual Scavenging has been a subject of study of our Interns and YFG Staff. Our newly-inducted Trustee, Advocate Abha Singh, is providing the push needed to take the study forward.

Advocate Abha Singh was a big help to an old woman, Parvati Shinde, who was being pushed around in the MHADA office though continuous efforts over two long years were made by our Consultant on RTI, Ranga Rao. Finally we asked Abha for help. She sent a legal notice to MHADA. It worked! More about this matter in our next Newsletter.

It is absolutely important to teach moral values to students because it is then that they take their first steps towards life and it matters that they do it right. The moral values that they learn & share shape their attitudes, beliefs and ideas. It also helps them develop into undeterred, morally strong Individuals.

School Children from Pragnya Bodhini High School, Anjuman Islam Girls High School, Purshottam High School, Podar International School (SSC), Sardar Vallabhai Patel Vividhalakshi Vidyalaya (SVPVV) and the Rabale community were introduced to values like happiness, relationship, compassion, kindness, resilience and emotions. Relationship with Self and Relationship with Parents were focused on. They were taught the intrinsic worth of HAPPINESS which can be achieved by having positive thinking and enjoying life.

A student's life is full of challenges, changes, growth and evolution. A growing child imbibes a lot of lessons throughout their student years, most of which stick with them for the rest of their lives. We have tried our best to reach to them individually & collectively. Students with high ethical values become accountable, responsible and honest people, while those without moral values to abide

by become a threat to themselves and society.

Values on Moral standards that define behavior and judgment about what is important in life were reiterated. Children were taught how human society cannot sustain itself if there are no values instilled in humans.

While there are an innumerable number of benefits of teaching values to our children, below are a few reasons that we focused on as to why it is important to teach values to students from a young age.

### 1. It Helps In Strong Character Building

Being aware of values from an early age helps in developing the child's character and forming the very core of their being. A strong character development happens because of the virtues and values that children learn during their childhood, which remains as a sound foundation for their moral beliefs in the future.

These values that children imbibe become their strengths, which they can rely on to decide their path in life. Therefore, the learning years are the time when special care needs to be

taken to instill these core values, which further get polished at school and later on in life.

### 2. It helps them in distinguishing Right from Wrong

Values serve as a guide in differentiating between right and wrong, right from the beginning. While we see almost every day that students at times can contribute to undesirable behavior like bullying or

cheating in exams, they usually do not understand the concept of right and wrong. Through our sessions we discuss, debate & share our thoughts & feelings.

According to research, children who commit petty thievery or pilfer were missing a parent or did not have any adult guidance to teach them proper values. Therefore we found it important to correct children when they do something wrong because they do not really understand what they are doing unless they are taught the difference between right and wrong. If children are not corrected for their small mistakes, they tend to understand that it is perfectly fine to continue doing it again. These small mistakes can later become a factor that will lead to poor personality development in children.

By teaching children these virtues, we help them form a firm basis of right and wrong, so they can conclude scenarios as morally right or not. This will help them in making the right decisions in their lives.

### 3. Boosts Self-Confidence And Positivity

While the children enjoyed the discussions and sharing of views it built up their confidence and in turn helped them to think positively.

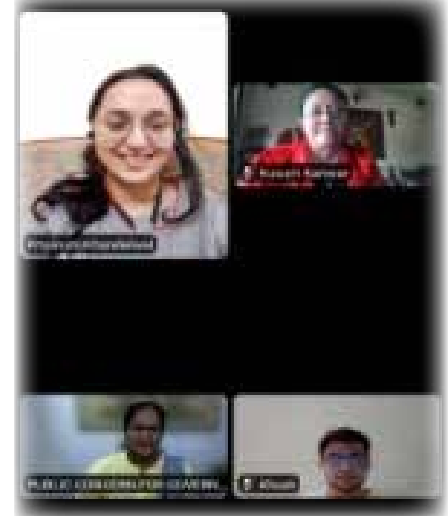

R – Righteousness

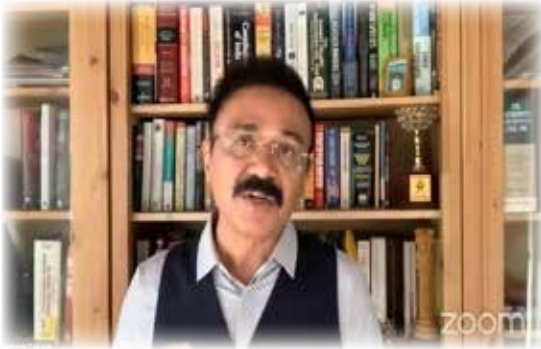
My learning from Kuchh Aur was that social change will happen only when there are change makers.”

### “Pegasus – Right to Privacy v/s A Surveillance State”

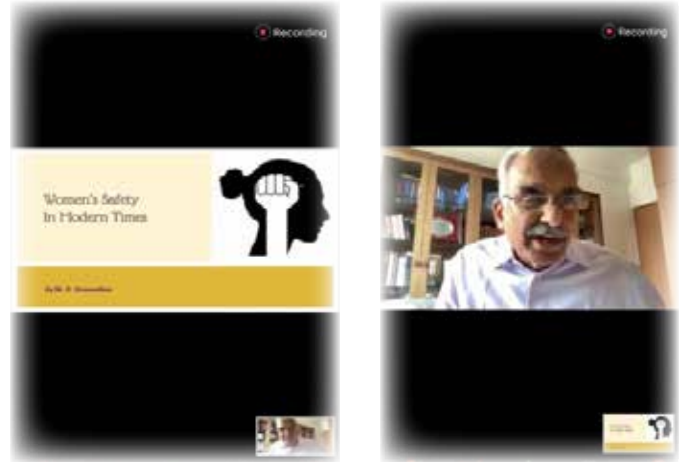

## TRAINING PROGRAMME ON RTI AND RTS

A One-day Online Training Programme on Right to Information (RTI) and Right to Services (RTS) was organized by Public Concern for Governance Trust in association with SVKM's Pravin Gandhi College of Law on Sunday, March 27, 2022 on Zoom. This was the third annual training programme, in furtherance to the success of a similar training programme organized by PCGT in February 2020 at the Indian Merchants' Chamber (IMC), Churchgate, Mumbai and in March 2021 online.

The training programme this year was organized with the assistance of the Lead Campus Ambassadors (Lead CAs), the Campus Ambassadors (CAs) and former interns of PCGT and witnessed participation of around 80 students and young professionals across the country. The Opening Address was delivered by Mr. J. F. Ribeiro, who shared the vision and

mission of PCGT with the participants and highlighted the importance of youth in ensuring that the government is transparent and accountable. This was followed by a session on "Demystifying Governance" delivered by Mr. V. P. Raja, which helped the students better understand their rights and duties vis a vis good governance.

A session on "Right to Information: Constitutional Perspective" was delivered by Adv. Shivam Jain Kakadia, who highlighted the constitutional relevance of freedom of information in a democracy. This was followed by a session by Mr. D. S. Ranga Rao on "RTS with special emphasis on the Maharashtra Right to Public Services Act, 2015", who gave practical insights to the participants about this important piece legislation. The last session was delivered by Mr. Shailesh Gandhi, who briefed the participants about the RTI Act, its recent amendment,

judicial backlogs as well as the issue of privacy of citizens. He then focused on the drafting and filing of RTI Applications and guided the participants in drafting RTI Applications and framing their queries better.

The aforesaid training program therefore served as an ideal platform for students and professionals alike to understand the importance of good governance as well as legislations such as RTI and RTS that lead to accountability in governance. The Lead CAs and CAs also got exposed to the nuances of organizing an event, thus honing their leadership skills and strengthening the CA programme as a whole. To obtain certificates for the training program, each participant was required to file an RTI Application to ensure that they have not only understood the law, but also put the training to use by actually filing an RTI Application within four months of the training.

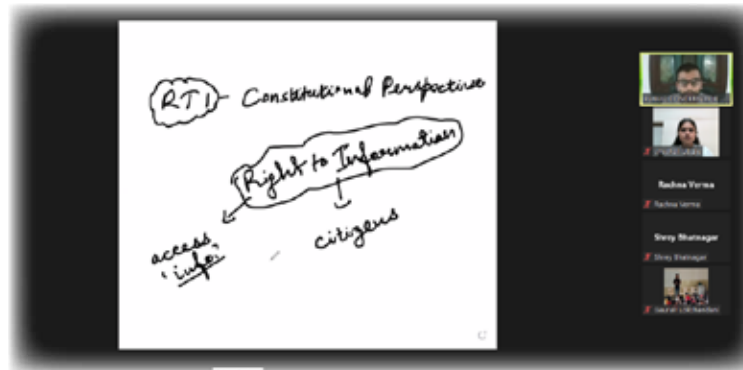
