250 Naiks and Constables underwent training on 'Compassionate Policing' at the Police Training Centre (PTC), Marol, from June 17 to 20, 2019, in a unique programme. Men who had been averse to the idea of undergoing training and would even 'pay' to avoid being sent for the training, had declared by the last day that they would now 'pay' to attend such trainings !! Such was the effect of the 'Compassionate Policing Programme' (CPP).

The programme was inaugurated at 9 a.m. on June 17, 2019, with lighting of the lamp by PCGT Trustees Dr. R. K. Anand, Mr. M. R. Reddy, Ms. Rekha Shahani; Principal of the PTC, Mr. Somnath Gharge and Mr. Keshav Patil Spl. IG (Training). The dignitaries then inspired the participants and gave them an overview of the workshop.

2 EDITORIAL



It is that time of the year once again. The time when the temperatures s 0 а r northwards and the

humidity levels rise up. The two together provide perfect conditions for the infections, viral or bacterial to germinate, prosper and spread. And they take in their wake the vulnerable among the populace as victims to the infections that follow. So it's that we hear that children. the most precious but most vulnerable of human beings have fallen prey yet again to the scourge of Encephalitis. Media has reported that over 150 children have succumbed to this dreaded disease already in the district of Muzaffarpur in Bihar and that it is spreading. It is not the first time that children in such large numbers have succumbed. Earlier Gorakhpur in neighbouring Uttar Pradesh had been similarly affected.

The victims probably suffer from a double whammy. Firstly, being Children they are more vulnerable, moreover hailing from economically vulnerable sections, the Society does not seem to care as much as it would probably if they belonged to the upper crust. What else explains the fact that so many children are lost year after year and except for some press reporting when incidents occur, there is no systemic effort to prevent such deaths.

The country boasts of institutes international of eminence which specialise in the study of viruses and other microbiological organisms. Is it not possible to devote time and effort to find out what could be the preventive mechanism for Encephalitis? Every State in the country has several departments charged with the welfare of rural folks. Rural Development Department, Health Department, Child Welfare Department, Social Welfare Department and so on. Is it too much for Secretaries of these departments to map the areas vulnerable to the Encephalitis, map the Socio economic sections of the Society vulnerable to it and then take active preventive measures to prevent children from falling prev to this dreaded disease. Such mapping would also indicate the places where super speciality facilities needed to be created where patients suffering from Encephalitis could be given best possible care.

One marvels at the silence of the Human Rights Commissions, both at State and Central level. Do they not consider this issue to be worth their effort? And what about Children's Commission? What do they wait for? Are not children and their well being their sole concern? We are grateful that Hon. Supreme Court has issued notice to State and Central Governments based on a PIL filed by some advocates. However, it appears that the PIL is directed mainly on treatment of affected patients in hospitals. What we need, however, are comprehensive orders and directions from the Honourable Court looking into all aspects of the matter.

For far too long this country and we as a Society, have tolerated obliteration of the young one. It is time that we rose to hold the States and their Departments accountable for the deaths year after year.

The objectives of the training were :

- Setting inspiring goals in alignment with a larger understanding of their role.
- Communicate with the public in compassionate and caring ways (thereby enhancing the perception of the Police)
- Deal with Women, Children and Senior Citizens sensitively
- Foster and Support Community Policing, and
- Do all the above with maximum joy and minimum stress.

In his speech, Mr. Reddy shared his views about police in the present context. He felt that post independence, things had changed but the police system operated in the same way as preindependence.

Dr. Anand, through his speech conveyed the importance of family life, healthy living habits, smiling and laughing and remaining at peace with oneself.

The sessions started at 6.30 a.m. and were titled 'Soul Nurture'. Ms. Rekha Shahani shared with the group the importance of nature, its contribution to human life and how in silence we should listen and be one with nature. 20 minutes of quiet time was given to the participants to listen to their inner voice and reflect upon their life. The participants later shared their thoughts which contributed in building a bond amongst them.

The training consisted of different resource people from various professions

 doctors, educators, theatre and film personalities, activists, along with people in authority in the police contributing to this training.

Mr. Subodh Jaiswal, DGP Maharashtra, who has started this training, has entrusted to PCGT the running of this content. This is going to be an ongoing session and Trustee Ms. Rekha Shahani is in charge of it.

For a two way hearing, while pinteracting with the participants, the educators and resource people came to know of the difficulty that the police face and the gross adversities that they work in and still retain a positive attitude. They not only had long duty hours,

but did not get time for regular meals, worked in strenuous conditions and at times faced a lot of humiliation within the department and from outside public. Some of the remote areas did not have enough staff to handle severe cases without adequate support.

In the beginning of the session, participants were hesitant to open up and share their thoughts. However, the four days journey of quiet time, reflection, sharing and using theatre as a tool of communication helped the participants to relax and be stress free. Mr. Pathik Vats, through his movie 'Sarfarosh' conveyed the role of police in a positive manner. He brought along Mr. Mukesh Rishi who essayed the role of 'Salim' in the movie, as an honest officer. All participants interacted with him and his focus was on how the police needed to take care of their physical self.

Dr. Harish Shetty spoke about emotional and mental health. Through his slides and humour he

touched upon various kinds of emotions like love, fear, jealousy, anger, hatred, happiness, shame, sarcasm, and made the participants realise the value of emotions and how to handle them. A well drafted schedule by Rekha Shahani touched not only the 220 constables and 50 senior inspectors present there, but also their families. Through her session on relationship, gratitude and forgiveness many constables called up home to express their gratitude to their families.

The final day witnessed a wonderful session in nature conducted by Ms. Rekha. The participants celebrated religious diversity and spiritual oneness wherein there were recitations of scriptures from various faiths. A Maharashtrian said a Zoroastrian prayer, a Hindu recited a Sikh prayer, a Brahmo recited from the Bible and so on. It was indeed blissful and peaceful. Mr. Subodh Kumar Jaiswal, DGP Maharashtra, in his speech expressed his faith that the training would benefit the police and stated the reasons why he would like PCGT to conduct the training.

RTI SUCCESS STORIES

RTI HELPS TO GET CORRECTED MARK-SHEET

The struggle to get corrected mark-sheet of Ms. Arina Pakhare who passed out from Nirmala Niketan College of Social Work was finally over. Ms. Pakhare approached PCGT in October 2018 complaining that the Mumbai University did not give her corrected mark-sheet despite her protracted correspondence with them. She was declared failed in two subjects of MSW Semester II. She had applied for revaluation. Then she applied for a copy of the answer sheet of the failed paper. She got it and when she calculated the marks, she found she had passed. She then kept on writing to the University through the college. For 2 years, the varsity did not respond to college letters. Finally, she approached PCGT who assisted her in filing four RTI applications and appeals. Finally, the varsity had to give her the corrected mark-sheet as per the direction of the State Information Commissioner.

END OF FOUR YEAR STRUGGLE WITH THE INTERVENTION OF PCGT THROUGH RTI

Mr. Ramesh Chawla tried in vain to get the licence of his deceased father's shop transferred to his mother's name even after submitting all the documents on a Legal Heir Basis.

Then Mr. Chawla gave a complaint letter on 27/10/2016 acknowledged by Market Dept. of the MCGM but till April, 2018 there was no response to the same. The Market Dept. continued to harass Mr. Chawla on one or the other pretext without transferring the license, or rejecting his application for the same.

Then he approached PCGT for help. With the PCGT's intervention through the RTI process leading to Second Appeal, the Information Commissioner directed the Assistant Commissioner of Market Dept. of MCGM for the desirable action, which finally resulted in Mr. Chawla getting what he wanted.
