## **EXPOSURE VISIT TO RAJGURUNAGAR**

CGT organized an exposure visit for the urban youth in the rural area of Rajgurugar in Khed Taluka, Dist. Pune. The Bombay Mothers and Children Welfare Society hosted 10 people from PCGT. Following are the activities conducted by PCGT at Rajgurunagar :

Session on Cyber Security and Women and Child Safety at Trimurti Vidyalaya. This session was conducted to raise awareness about cyber security and safety, specifically targeting women and children. It was attended by around 170 students at Trimurti Vidyalaya. The same session was conducted for community adult members at the Bombay Mothers and Children Welfare Society office. More than 35 people attended the session.

E n d i n g September 2023

Do take a moment to peruse the reports of our three verticals – the Kuchh Aur,

the Youth For Governance and the Leadership Programme. Specially, read the views of the young people who participated in those programmes. If they think they have gained in knowledge and, more pertinently, in confidence, then the Trustees and Staff of the P.C.G.T. will be assured that their time and energy spent on pursuing the goals of the organization have not been wasted.

Our Chairman, V.P.Raja, was away for four months touching base with his daughter and his son, settled in the United States. In his absence I interacted with the Interns and our Staff more regularly than before. I was happy to note that the interns were participating in the discussions and learning how government offices and the police stations function and deliver justice to the citizens.

P.C.G.T. arranged for the young interns to visit and interact with the "Right to Service" Commissioner, who spoke to them about the State's law on the disposal of files in State government offices, the right of supplicants to speedy disposal of their grievances, and channels available for complaints. Most grass-roots corruption is based on delays in disposing of files. If our interns spread the knowledge about this new Act it will help citizens to get their dues more easily. Even Government officials who should be in the know about this Act and be in dread of it, are not aware of its provisions and the consequences of not disposing of files within the prescribed time. If the R.T.S. Commissioner wants PCGT's help to make this Act as well known as the R.T.I. is today, our students can be involved in the task. We are available and ready.

The interns also visited a Police Station and police offices fighting Cyber crime and protecting women and children from molestation. Activists and experts in different disciplines spoke to our Interns and interacted with them in the P.C.G.T. office. An intern in the last batch sprang a pleasant surprise on us by presenting us with a cheque of INR 2000/- from his father. This is the Second such instance of appreciation shown by interns, the first being a cheque for INR 10,000/- from the father of a young girl who interned with us a few years ago. These are small gestures of appreciation of our work which help us to measure success.

The former interns who volunteered to visit Rajgurunagar, where a N.G.O., of which I am incidentally the Chairman, has been working for the past 25 years or more trying to ameliorate the standard of education and living of our rural citizens, addressed the school children on the benefits of the R.T.I Act, the purport of the POCSO Act and the need of Cyber security. The Secretary of the NGO, Dr. Madhav Sathe, a committed social worker, told me that the Adivasi students with whom our interns interacted were truly enlightened and benefitted from their contact with the urban youth. Our students were equally happy.

Because of our precarious financial situation we may find it difficult to continue with these rural visits without some financial contribution from our interns. I have broached the suggestion to prepare them for this possible eventuality. It is only the hiring charges of the transport that may have to be met from the contribution of the students. The Bombay Mothers and Children Soci8ety will accommodate and feed our students.

Our Kuchh Aur programme across different schools and communities

goes on apace. Just read the reaction of some of our interns who have been exposed to our endeavours. Many interns are so enthused on noticing the interest with which school kids participate in our valuesaddition exercise to their prescribed curriculum that they themselves take the podium and speak to the kids about their own experiences while pursuing that particular value that is being discussed.

Our Annual "National Youth Parliament" was held in this Quarter on August 19 and 20 at the Pravin Gandhi College of Law, our oldest and most consistent partner. Some 200 students from across the country participated in this project. A brain-child of our Consultant, Advocate Shivam Jain Kakadia, it has an in-house Student's Organizing Committee. Members of this Committee gain in confidence and develop leadership qualities of a high order because of the responsibilities cast on them individually. A Retired Judge of the Bombay High Court, Justice S. C. Gupte, presided. P.C.G.T. Trustee Gulam A. Vahanvati was our representative and the College was represented by its Principal, Dr. Navashikha Duara.

Consultant Kakadia was also successful in cementing an M.O.U. between P.C.G.T. and the Maharashtra National Law University (M.N.L.U.). The Vice-Chancellor, Prof (Dr.) Dilip Ukey signed the M.O.U. for M.N.L.U. while Adv. Kakadia signed on behalf of our Chairman, V.P. Raja, IAS (Retd.), as he was travelling abroad.

A new batch of Lead Ambassadors and Campus Ambassadors took charge on 20th August. They will organize a series of talks by experts in their respective Colleges. The subject of the talks is chosen by the students of each college. If the students approach PCGT to arrange for experts to speak on the chosen topic, PCGT Trustees are always available to help.

n this quarter, PCGT had interns from Dr. D. Y. Patil School of Law, Government Law College, Maharashtra National Law University, Jindal Global Law School and KES' Shri Jayantilal H. Patel Law College. They got an opportunity to attend talks by eminent professionals and visit various government agencies. They acquired both practical and theoretical knowledge regarding pressing social issues throughout their one-month internship programme.

Mr. Shivam Jain Kakadia, Consultant -Youth For Governance (YFG), PCGT, interacted with the interns on the topic of Centre-State Relations, Rule of Law and Importance of Role Models where he discussed the powers of parliament to amend the constitution through timeline of various case laws, the three principles of A.V. Dicey and the basic structure of the constitution.

Mrs. Renu Kapoor, a practicing Chartered Accountant inspired the interns to Act whenever they see anybody's rights being violated. She spoke about portals and toll-free lines that people can call to raise their concerns to the government authorities. During his 'Cyber Safety' session, he spoke about various cyber crimes committed and provided tips on how to stay safe online, safeguarding personal information and digital well-being in this digital world. ## PCGT LEADERSHIP PROGRAMME

Public Concern for Governance Trust (PCGT) and Common Cause (NGO) supported the Indian Police Foundation (IPF) in organizing the IPF Foundation Day / Police Reforms Day Programme on Friday, September 22, 2023 from 4 pm to 6 pm at the Hall of Culture, Nehru Centre, Worli, Mumbai.

Hon'ble Mr. Justice Gautam Shirish Patel (Judge, Bombay High Court) presided as the Chief Guest for this programme and shared his views on the landmark verdict of Prakash Singh v. Union of India (decided on September 22, 2006), in which the Hon'ble Supreme Court issued seven binding directions on police reforms

in India. Other keynote speakers including Mr. Vipul Mudgal (Director, Common Cause), Mr. Prakash Singh (Patron, IPF; IPS Retd.) and eminent Senior Advocate Mr. Mihir Desai also opined on the aforesaid verdict on police reforms with special emphasis on the status of its implementation.

A special highlight of the event was the felicitation of our Chairman Emeritus, Mr. Julio F. Ribeiro. Recognising his exceptional contributions to law enforcement, a citation was presented to Mr. Ribeiro on behalf of the IPF and the entire Indian Police fraternity. Mr. Deepak Parekh, former Chairman HDFC & Member of the IPF Executive Committee, read out and presented the



citation to Mr. Ribeiro.

"After observing the political shenanigans from within the police and outside, I am convinced that all the governments in the country only pay lip service to the Supreme Court's directions on police reforms (in Prakash Singh v. Union of India)" Mr. Ribeiro said while thanking the IPF for the honour. He added that citizens should "publish the names" of the officers who are "honest, efficient and whom they trust to ensure the safety of the people and security of the property." The programme concluded with a vote of thanks by Mr. Satish Sahney (Former Commissioner of Police, Mumbai).
